Takeaway messages after the 1st review meeting in Brussels

"Work on WP8 is progressing as planned, a good overall coverage on local and social media but":

- "dissemination and exploitation plan in the DoA should be updated and provide KPI to support impact and ensure efficient use of resources"
- "demonstration events (Task 8.4) should effectively involve potential end-users of innovative project results" – we're multi-actor
- "Practice Abstract is not always convincing regarding the content, language and graphic presentations" – one size fits all





Takeaway messages after the 1st review meeting in Brussels (2)

- "the publication list is still quite limited" impact?
- "several publications do not have the EC disclaimer or do not have correct disclaimer" – financial fines!
- "the Consortium has to publish in gold or green open access" financial fines!
- "publications and underlying data should be deposited in open access" – zenodo (autumn 2018)
- "achieving a better balance between publication of scientific results and the protection and exploitation of the IP" - capitalization









































Partners duties

- Establishing contact list of IPR managers with project partners
- Draft of deliverable D8.1 Dissemination and IP Transfer Structure and Programme (DTSP)



Plan for Y3

- Selection of project partners planning to commercialize project results
- Draft and distribution of business plan survey
- Development of business plans for selected project partners
- Drafting Interim Plan for Use and Dissemination of the Foreground
