GATHERING AND ACCESS TO THE FIELD

In Vodice: In the field on the road from Vodice to Bukovica - if you are coming from the direction of Komenda, turn left in Vodice at the agricultural cooperative towards Bukovica, continue over the new bypass and after 400 m turn left on the dirt road towards the rubbish dump to the experimental potato field of the Agricultural Institute of Slovenia. From the direction of the motorway, turn right at the cooperative and continue as described above.

In Jablje: At the Jablje site, the presentation will take place in the organic experimental field of the IC Jablje.

Access: from the Trzin-Mengeš road, at the junction for the Agricultural Institute of Slovenia's IC Jablje, turn left into the field. After about 2 km on the road to Domžale, the potato experimental field of the CRP and ECOBREED projects is on your left.
